

GIFTS OF STOCK

MAXIMIZE YOUR IMPACT, MINIMIZE TAXES

Donating appreciated securities, such as stocks, bonds or mutual funds, is one of the most tax-efficient ways to give in Canada. When you donate securities directly to Lions Gate Hospital Foundation, you eliminate the capital gains tax and receive a charitable tax credit for the full market value of your donation. This allows you to make a larger impact while providing valuable tax savings.

HOW TO MAKE YOUR GIFT OF STOCK

1. Use the attached Letter of Direction or scan the QR code to access a fillable version online.
2. Instruct your broker to transfer appreciated securities directly to Lions Gate Hospital Foundation.
3. We will sell the securities and issue a tax receipt based on the shares' closing price on the date they are received.
4. Your gift is exempt from capital gains tax, and you can use the donation tax credit to offset other taxes payable.

ELIGIBLE SECURITIES

- Publicly traded shares
- Bonds
- Mutual fund units

YOUR BENEFITS

- ✓ No capital gains tax on the donated securities
- ✓ Tax receipt based on the share's closing bid price on the date we receive them

Capital Gain	\$40,000
Taxable Portion of Gain	\$0
Taxes Owed	\$0
Gift to LGHF	\$50,000
Donation Tax Credit	\$26,683
