



Suggested Will Wording

We are pleased to discuss with you or your financial/legal advisor about the many different types of bequests and the ways to designate your gift to an area of your choice, including discussing the tax benefits of specific gifts. Below are some broad guidelines for ensuring your gift to Lions Gate Hospital Foundation is received as you intend.

When you draft or revise your Will, provide your lawyer, notary, or advisor with instructions to leave a bequest to:

Specific Bequest

Use to leave a specific sum of money or property (eg. Real estate, stocks, bonds, or other articles as agreed between the donor and the Foundation)

""I give to LIONS GATE HOSPITAL FOUNDATION, Charitable BN# 119020907RR0001, currently of 231 East 15th St., North Vancouver, British Columbia, V7L 2L7 the sum of \$ [insert amount]"

e.g., 100 shares of Royal Bank of Canada

Residual Bequest

Use to give Lions Gate Hospital Foundation all or a percentage of what remains of the estate after paying debts, taxes, expenses, and other bequests.

"I give to LIONS GATE HOSPITAL FOUNDATION, Charitable BN# 119020907RR0001, currently of 231 East 15th St., North Vancouver, British Columbia, V7L 2L7 all (or stated percentage) of the rest, residue, and remainder of my estate..."

Contingent Bequest

Use to give a gift that only takes place if the Testator is not survived by certain individuals.

"If (name/s of primary beneficiary/ies) does not survive me, or shall die within thirty (30) days of my death, then I give to Lions Gate Hospital Foundation (describe amount of cash, property or percentage of residual interest)..."
